Reflective Practice: Formation and Supervision in Ministry is a journal that seeks to understand, expand, and promote theory, learning, and reflection in the practice of formation and supervision in various ministries from diverse ethnic and religious perspectives. This journal welcomes essays and readers from a wide range of disciplines, but the practice on which we reflect remains focused on formation and supervision in and for the sake of strengthening religious leaders. Only articles related to these goals will be considered for publication. **Reflections on formation and supervision in ministry from nations and cultures outside the United States are especially invited.** Book reviews are also welcome.

AUTHOR GUIDELINES: Authors should submit their articles electronically to the editor, Scott Sullender, at ssullender@sfts.edu. Articles should not exceed twenty pages double-spaced. Notes should be indicated with superior numerals and placed as endnotes at the conclusion of the article. A cover sheet should give the title of the article, the author's (or authors') academic degrees, name, title, institution, and mailing and email addresses. The decision to publish an article will be made by readers from the journal's editorial board and others whose expertise relates to the topic of the essay. A more complete statement of author guidelines is available on the journal's website. The initial deadline for all submissions for volume 39 is January 30, 2019. With the editor's permission, the final deadline is February 28, 2019. The publication date is May or June of each year. Each volume is available free online, and a hard copy is mailed to paid subscribers.
